PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. May cause irritation of nose, throat, eyes and skin. Protective clothing (long pants, long sleeve shirts, gloves, hat and boots) must be worn during mixing and loading. Use of rubber gloves is recommended. Avoid inhalation of any dust from treated seed. Wear a pesticide respirator jointly approved by the Mining Enforcement and Safety Administration and by the National Institute for Occupational Safety and Health under provisions of 30 CFR Part II. Wash thoroughly after handling and before eating, drinking or smoking. Treat seed in a well ventilated place. Do not graze or cut green forage for livestock feed from fields planted with treated seed.

Treated seed must not be used for or mixed with food or animal feed, or processed for oil. Seed commercially treated with GRANOX Plus Flowable must be labeled in accordance with all applicable requirements of the Federal Seed Act.

STATEMENT OF PRACTICAL TREATMENT: If swallowed, induce vomiting by drinking 1 or 2 large glasses of water and then touch back of throat with finger. Repeat until vomit fluid is clear. Get medical attention. If in eyes, flush with clean water for at least 15 minutes and then get medical attention. If on skin, wash with soap and water.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Exposed treated seeds may be hazardous to birds and other wildlife. Dispose of all treated seeds by burial away from bodies of water.

PRODUCT INFORMATION: GRANOX Plus Flowable is a special seed treatment formulation of maneb and thiabendazole fungicides which, when used at the correct dosage rate, protects wheat against the seed-borne disease Stinking Smut (Bunt) of Wheat. It also protects wheat against certain seed and soil-borne diseases causing Seedling Blight.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

STIR WELL BEFORE USE. Use at temperatures above 0°F.

Use GRANOX Plus Flowable in liquid and slurry seed treaters at the following rates:

Wheat - 1.6 fl. oz. per bushel

Use only recommended rates - lower amounts may not give the desired control. Higher amounts may cause seed injury. Seed should be well cured, dried and cleaned before treatment. For maximum benefits avoid deep seeding and exceptionally early sowing under poor growing conditions.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store above 0°F. Product stored at a lower temperature will reconstitute to satisfactory utility if warmed to approximately 70°F and thoroughly shaken or stirred before use. Keep container tightly closed when not in use. Store treated seed in a well ventilated place away from water, food and feed.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse, then puncture and dispose of container in a sanitary landfill or by other procedures approved by State and local authorities.
