CAUTION

AGROSOL T, when used at the correct rate, protects seeds from soil and seed borne diseases that cause damping-off, seed decay, seedling blights, and pod and stem blight (*Phomopsis* spp) during germination and early seedling stages.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labelling.

STIR WELL BEFORE USING. Use at temperatures above 40°F. Use AGROSOL T in liquid and slurry treaters at a rate of 4 fl. oz. per bushel of soybean seed (6.6 fl. oz. per 100 lbs. of soybean seed).

NOTE: The purchaser of this product is responsible for insuring that all seed treated with this product are adequately dyed with a suitable color to prevent its accidental use as food for man or for animals. Refer to 21 CFR, Part 2.25. Any dye added must be cleared for use under 40 CFR, PART 180.1001.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store above 32°F. Product stored at a lower temperature will reconstitute to satisfactory utility if warmed to approximately 70°F and thoroughly shaken or stirred before use. Keep container tightly closed when not in use. Store away from water, food and feed.

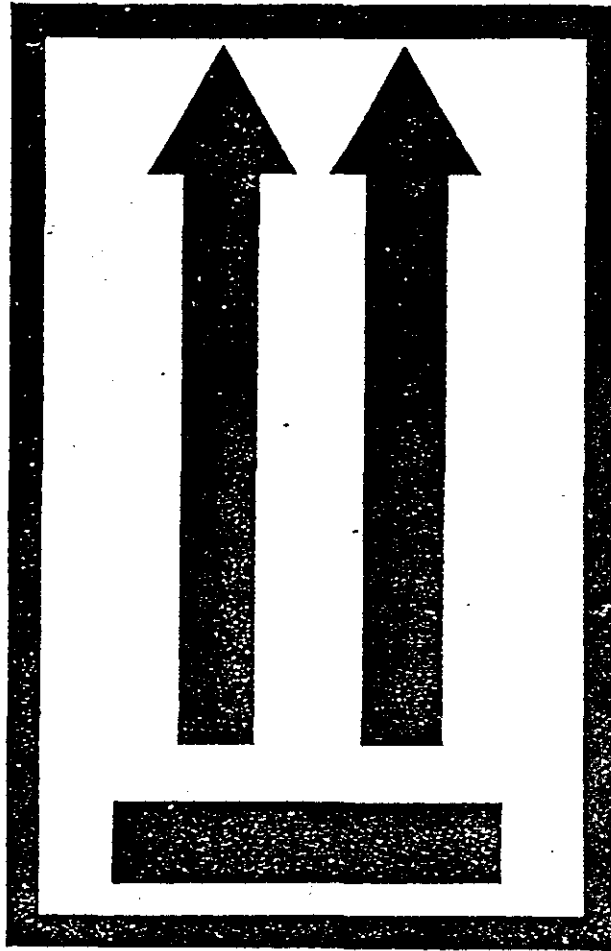
