STATEMENT OF PRACTICAL TREATMENT

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.

IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

1. Wet coat with warm water.
2. Pour shampoo along pet's back.
3. Work shampoo into coat without getting lather in eyes. If so, wash eyes quickly with clean water to prevent irritation.
4. Leave lather on pet for five minutes to permit insecticide to take full effect.
5. Rinse thoroughly.

TICK CONTROL:

1. Apply a small amount of shampoo directly to ticks present after final rinse.
2. Comb out dead ticks later.

STORAGE AND DISPOSAL

STORAGE: Store at room temperature.

DISPOSAL: Securely wrap original container in several layers of newspaper and discard in trash.
