**CAUTION:** This collar is intended for use as an insecticide generator and is not to be taken internally by man or animals. Not intended for use by humans. Do not allow children to play with this collar. Wash hands with soap and water after handling collar. Do not use on sick or debilitated animals or cats under 12 weeks of age.

Do not use other cholinesterase inhibiting insecticides on your animal while wearing collar. Some cats may be sensitive to this collar. Remove at first sign of irritation or adverse reaction (muscular tremor, salivation, vomiting and/or diarrhea). The insecticide in this collar is a cholinesterase inhibitor.

Note to Physician/Veterinarian: Atropine only by injection is antidotal. Use only if symptoms of cholinesterase inhibition are present.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

The VICTORY II<sup>®</sup> Collar for cats contains Dursban<sup>®</sup> insecticide, one of the longest lasting flea and tick killers available for use on cats. This collar will retain its maximum effectiveness within 2 to 3 days after placing it on the cat and will

continue to protect your cat against fleas up to 11 months and ticks up to 6 months. Ticks, if should be noted, are only occasional and usually temporary pests of cats.

Place the collar around cat's neck, buckle and adjust for proper fit. Cut off and dispose of excess length. The collar must be worn loosely so that two fingers may be placed between collar and cat's neck. If collar is worn too tightly, it may produce neck irritation. Fleas and ticks present in the cat's environment that may reappear on your pet will be killed by action of this collar. Collar's effectiveness is not diminished by normal wetting such as rainfall; however, it is suggested that collar be removed before bathing.

### DISPOSAL

Do not reuse empty box, pouch or collar. Wrap in newspaper and put in trash collection.
