CAUTION

Harmful if swallowed. Avoid breathing vapors. Do not spray in eyes, face or on genitalia of pets. Do not use on nursing kittens under 3 months of age. Do not use this or any other pesticide on sick, old, or debilitated pets.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Drink one or two glasses of water and induce vomiting by touching the back of the throat with finger. Repeat until vomit fluid is clear. Call a physician immediately. Do not induce vomiting or give anything by mouth to an unconscious person.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

IF ON SKIN: Remove contaminated clothing and wash affected areas with soap and water. Get medical attention.

IF IN EYES: Flush eyes with plenty of water. Call a physician if irritation persists.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USING

Hold bottle upright and point nozzle in desired direction of spray. Spray the animal from a distance of 8 to 12 inches. Start spraying at the tail moving the dispenser rapidly and making sure that the animal's entire body is covered including the legs and under the body. Wear protective gloves. While spraying fluff the hair so the spray will penetrate to the skin. Make sure spray wets thoroughly. Do not spray into eyes, face, or on genitalia. Repeat as needed.

PHYSICAL OR CHEMICAL HAZARDS

Do not use or store near heat and open flame.

STORAGE AND DISPOSAL

STORAGE: Store in a cool area away from heat and open flame. Keep from freezing.

DISPOSAL: Do not reuse empty container. Wrap original container in several layers of newspaper and discard in trash.
