LAWNS AND YARDS: Fire Ants, Red Harvest Ants and other small Ants: Dust hills thoroughly mixing dust in top 2 or 3 inches of soil with rake. Dust around foundations of buildings or house. Dust lawn area at the rate of 1 pound per 1,000 sq. feet for control of Scorpions, Centipedes, Mole Crickets, Crickets, Fleas, Earwigs, Chiggers, Ticks, Fall Armyworms, Chinch Bugs, Grass Termites and Sod Webworm or Lawnmoth. Repeat in 12 to 14 days or when necessary. Water lawn before application, but do NOT water for several days thereafter.

FLOWERS: Such as, Chrysanthemums, Roses, Dahlias, Zinnias, for Thrips, Grasshoppers, Flea Beetles, Armyworms, Leaf Miners, Cucumber Beetles: Dust plants thoroughly and repeat in 10 to 14 days if necessary.

CAUTION: Avoid breathing dust. Avoid contamination of feed and food-stuffs, wash thoroughly after handling. Burn container when empty and stay out of smoke. Keep children and pets off treated areas until the area is well watered and has dried completely.

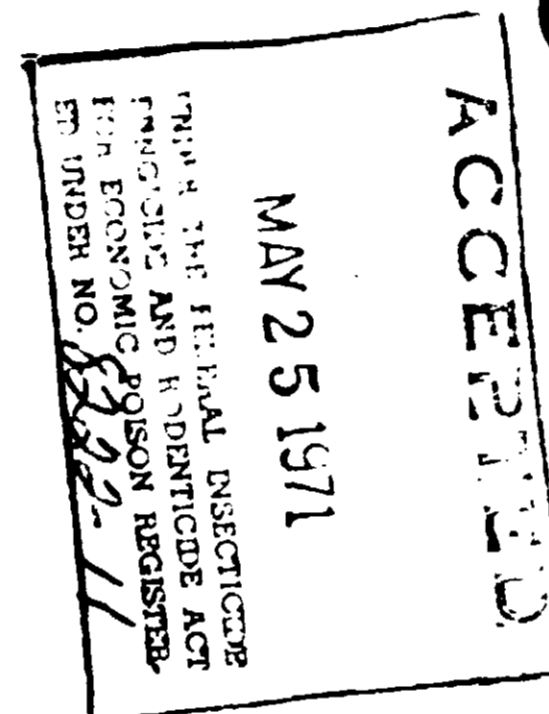
