DIRECTIONS FOR USE

Shake well before using.

Spray a fine mist of T & C Dog & Cat Repellent on the plants from the ground line up to a height of 12 to 18 inches on larger shrubs, flowers and ornamental trees. For small flowers and grass spray entire plant with a fine mist. Make a quick pass with the spray over the plant to prevent overspraying. Hold aerosol can at least 15 to 18 inches from the plant when spraying. Do not wet plant with spray to point of run-off. Repeat when necessary. This will be determined largely by weather conditions.

It is important to spray the edge of flower and shrubbery beds. It is also important to clean fecal deposits as it often attracts stray animals. This product should be used every other day.

NOTE: The most effective control for a pet is the sharply spoken word backed up with disciplinary action. This product should be used in conjunction with disciplinary training.
