

**USE STRICTLY IN ACCORDANCE WITH LABEL DIRECTIONS**

Dust early in the morning or late in the evening when the temperature is low and the air is still for best results. Apply dust so all exposed parts of plants are covered especially upper and lower leaf surfaces.

KILLS APHIS on tomatoes, beans, brussel sprouts, cucumbers, cantaloupes, potatoes, carrots, head lettuce and cabbage. SPIDER MITES on cucumbers, cantaloupes, tomatoes, head lettuce, squash and watermelons. LEAF HOPPERS on beans, head lettuce, potatoes, carrots, cantaloupes and watermelons. CUCUMBER BEETLES on cucumbers, squash, cantaloupes and watermelons. FLEA BEETLES on beans, brussel sprouts, egg plants, peppers, cabbage and tomatoes. For LATE and EARLY BLIGHT of potatoes and tomatoes, for DOWNY MILDEW of beans, cucumbers, spinach, cabbage, brussel sprouts, head lettuce, squash, cantaloupes and watermelons. ANTHRACNOSE of cucumbers, cantaloupes, squash, tomatoes and watermelons, for plant disease, start program of dusting as soon as foliage appears. Repeat at one or two week intervals for best protection. For insects apply when insects first appear Repeat application every 5 to 10 days or as necessary.

**CAUTION:** Avoid inhalation of dust. Avoid contact with skin. Wash hands after use. Keep out of reach of children. Avoid contamination of foodstuffs. Do not use within 14 days of harvest on crops and especially on brussel sprouts, spinach and lettuce. Remove residue from food crops by washing before use. 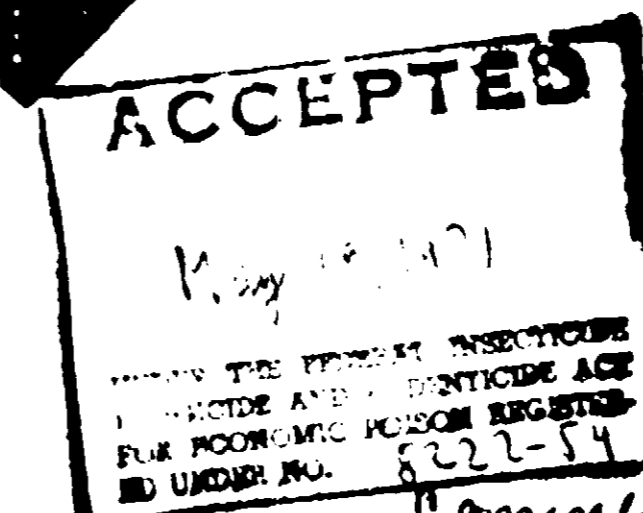
