Dear Registrant:

This letter replaces the letter sent to you on March 4, 1993. The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted. Another copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed to replace the one stamped March 4, 1994 which was previously issued.

WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the WPS labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. Any other labeling changes submitted in connection with this amendment application but not directly related to compliance with the WPS have neither been reviewed nor accepted by the Agency. If you wish to make such changes, you must submit a separate amendment application proposing them. If your product is currently suspended, the acceptance of this labeling amendment does not affect the suspension in any way.

STATEMENT OF PRACTICAL TREATMENT

After first aid is given take victim to clinic or hospital. If breathing has stopped, start artificial respiration immediately and maintain until doctor sees victim. If swallowed: Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Get medical attention. In case of contact, immediately flush the skin with plenty of water. See doctor immediately.

Symptomatic treatment including oxygen and artificial respiration for paralysis of respiratory muscles and/or hydrocortisone acetate, ephedrine sulfate, 30 mg. I.M. or amphetamine sulfate, 40 mg. I.V. (Reference: March Manual Poisons) See side panel for additional precautionary statements.
