The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided you make the following changes before you release the product for shipment bearing the amended labeling:

- 1. The preferred format for the First Aid statements is the boxed format with bullets (see PR Notice 2001-1 for example). All the category headings should be bolded, not only the "If Swallowed" heading. Add "Call a poison control center or decator for further treatment advice." to each category. You are encouraged to add a company telephone number or toll-free hotline number. You may use the National Pesticide Telecommunications Network (NPTN). See the enclosed pamphlet for more information.
- 2. Add a Note to Physician section/box with the following: "Carbaryl is a N-methyl carbamate the inhibits cholinesterase. Atropine is antidotal. Do not use 2-PAM (pyridene-2-aldoxime methiodide), opiates or cholinesterase inhibiting drugs. Probable mucosal damage may contraindicate the use of gastric lavage. Specific treatment....within 24 hours. To aid...immediately frozen."
- 3. Under the Precautionary Statements delete "May be..." so that the beginning of the statement begins: "Harmful is swallowed...." Also, in the last sentence revise "pests" to "pets."

### READ ENTIRE LABEL BEFORE USING

When used as directed, METRO (TESTED) ALL PURPOSE BUG BAIT will give good control of SNAILS, SLUGS, ANT, EARWIGS, AND SOWBUGS. Thoroughly water area prior to application. This product can be applied any time during the day, but late a fternoon or evening is preferred. M ay also be applied from a fertilizer spreader. Do not water area for 48 hours after application. When using the Shaker Can, simply shake on the proper amount from the shaker top can. Use at the rates as recommended on the front panel of this product label.

# AROUND ORNAMENTALS, OUTDOORS AND IN GREENHOUSES, IN FLOWER GARDENS and BORDER PLANTINGS, IN and AROUND GROUND COVERS.

Azaleas, Begonias, Camellias, Chrysanthemums, Daffodils, Dahlias, Daisies, Geraniums, Honeysuckle, Hydrangeas, Ice Plants, I mpatients, I ris, I vy, Marigolds, Pansies, Petunias, R hododendrons, R oses, S napdragons, S pathiphyllum, Sweet Peas, Tulips. Do not get granules on Boston Ivy. To control SNAILS and SLUGS, thoroughly water area to be treated. Withhold watering for 48 hours after treatment. Apply this material over the infested area and around the edges of border and ground cover plants. Apply also to the bases of fences and walls and in shady, protected areas. APPLY AT THE RATE OF ONE POUND per 1500 SQUARE FEET. Repeat treatment every 3 to 4 weeks during "season" or as needed for control.

To control ANTS, EARWIGS, & SOWBUGS, APPLY AT THE RATE OF ONE POUND TO 250 SQUARE FEET. Follow watering practices as outlined above. Repeat treatment every 3 to 4 weeks during "season" or as needed for control.

#### FOR DICHONDRA AND TURF LAWNS

To control SNAILS and SLUGS, water area to be treated thoroughly before application. Apply METRO (FESTED) ALL PURPOSE BUG BAIT at the rate of ONE POUND per 1500 SQUARE FEET. To control ANTS, EAR'VIGS, & SOWBUGS, APPLY AT THE RATE OF ONE POUND per 250 SQUARE FEET. Follow watering directions as outlined above. Repeat treatment every 3 to 4 weeks during "season" or as needed for control.
