DIRECTIONS

1. Shake well before using.
2. Turn spray valve so arrow points to red dot.
3. Hold can upright or upside down 8 to 10 inches from surface to be cleaned. When spraying upside down and spray stops, spray upright for a few seconds, then spray upside down again.
4. Allow foam to soak dirt. Wipe off with a clean cloth or sponge. No rinse needed.
5. When using on chrome, rinse with water to obtain a bright shine.

FOR USE TO PREVENT MOLD AND MILDEW

1. Spray surface until moist.
2. Repeat application in 14 days to maintain control.
3. Boat hulls - in dry dock only.
