**DANGER**

**CORROSIVE:** Causes severe eye and skin damage. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

**ENVIRONMENTAL HAZARDS:** Product is toxic to fish. Do not discharge into lakes, streams, ponds or public waters unless in accordance with a NPDES permit. For guidance contact your regional office of the Environmental Protection Agency.

**STORAGE & DISPOSAL**

- 1. PROHIBITIONS:** Do not use with soaps or synthetic or other disinfectants. Do not contaminate water and food. Open dumping is prohibited.
- 2. STORAGE INSTRUCTIONS:** Store in original container or approved container.

**STATEMENT OF PRACTICAL TREATMENT**

**DIRECTIONS FOR USE:**

**DISINFECTION:** Mix 1 tablespoon Mar-V-Cide in one quart of water, or make stock solution by mixing 2 ounces (1/4 cup) Mar-V-Cide in one gallon of water.

Completely immerse cleaned brushes, combs, razors, clipper heads, scissors, manicure instruments, etc for 10 minutes (or as required by local health authorities). Change Mar-V-Cide solution every two weeks.

**COLD DISINFECTION OF SURGICAL INSTRUMENTS:** Clean thoroughly, rinse, and immerse in a solution of one ounce of Mar-V-Cide to one gallon of water for ten minutes.
