### Conditions

Revise the label as follows:

Since this product is sold in containers less than one gallon, the "Pesticide Disposal" and "Container Disposal" sections should be deleted from the label. 1. The "Storage and Disposal" statement should read as follows:

# STORAGE AND DISPOSAL

Store in original container in an area inaccessible to children or individuals unfamiliar with the use of the product. Do not use with soap or synthetic other disinfectants. Do not reuse empty container. Discard in trash.
