Dear Mr. Marvy,

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

Addition of Foot Spa Directions

## Conditions

Revise the label as follows:

1. Remove the parentheses from around "foot spas" in the phrase "whirlpool foot spa units."

2. Delete the paragraph after "Special Instructions for cleaning and decontamination against HIV on surfaces/Objects soiled with blood/body fluids," because it is redundant.

3. Under the "Precautionary Statements" revise the "Wash thoroughly...after handling" statement to be in agreement with the Label Manual, 3<sup>rd</sup> edition by stating "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco."

3. Revise the "Whirlpool Foot Spa" directions to state "After using whirlpool foot spa, drain the water and thoroughly clean all hard, nonporous surfaces with soap or detergent. Rinse with water. Saturate surfaces with 2 oz of product per gallon of water to exposed surfaces with cloth, sponge, or sprayer. Brush or swab thoroughly and allow solution to stand for 10 minutes. After unit has been thoroughly disinfected, rinse all cleaned surfaces with fresh water."

#### **PRECAUTIONARY STATEMENTS** HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: KEEP OUT OF REACH OF CHILDREN.

CORROSIVE. Causes irreversible eve damage and skin burns. Harmful if swallowed. Do not get in eves, on skin or on clothing. Wear eve protection (face shield or goggles), protective clothing, and rubber gloves. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

#### STORAGE AND DISPOSAL

Store in original container in an area inaccessible to children or individuals unfamiliar with the use of the product. Do not use with soap or synthetic or other disinfectants. Do not reuse empty container. Discard in trash.

#### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. This product is not to be used as a terminal sterilant/high-level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to preclean or decontaminate critical or semi-critical medical devices prior to sterilization or high-level disinfection. For disinfecting, a precleaning step is required.

PREPARATION OF DISINFECTANT USE SOLUTION: Mix one tablespoon of MAR-V-CIDE in one quart of water, or make stock solution by mixing two ounces (1/4 cup) MAR-V-CIDE in one gallon of water.

DISINFECTION DIRECTIONS: Apply use solution to hard, non-porous surfaces such as floors. walls, cabinets, sinks, counters, tables, chairs, and telephones, thoroughly wetting the surfaces with a cloth, mop, or sponge. Treated surfaces must remain wet for 10 minutes, then allow to air dry. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution after each use.

BARBER/BEAUTY SALON INSTRUMENTS AND TOOLS: Immerse pre-cleaned barber/beauty salon instruments and tools (such as combs, brushes, razors, scissors, blades, and manicure instruments) in a use solution of 2 oz. per one gallon of water (refer to preparation of use solution) for 10 minutes. For heavily soiled instruments and tools, a preliminary cleaning is required. Rinse thoroughly and dry before use. A fresh solution must be prepared daily or more often if solution becomes diluted or soiled.

DISINFECTION OF HARD, NON-POROUS SURFACES IN WHIRLPOOL (FOOT SPA) UNITS: After using the whirlpool unit, drain and refill with fresh water to just cover the intake valve. Add 2 ounces of this product for each gallon of water at this point. Briefly start the pump to circulate the solution. Turn off the pump. Wash down the unit sides, seat of the chair, lift and any/all related equipment with a clean swab, brush or sponge. Treated surfaces must remain wet for 10 minutes. After the unit has been thoroughly disinfected, drain the solution from the unit and rinse any/all cleaned surfaces with fresh water. Repeat for heavy soiled units,

FUNGICIDAL DIRECTIONS: This product is an effective fungicide against Trichophyton mentagrophytes, agent that causes Athletes foot fungus, in areas such as locker rooms, dressing rooms, shower, and bath areas. Apply use solution to hard, non-porous surfaces such as floors, walls, cabinets, sinks, counters, thoroughly wetting the surfaces with a cloth, mop, or sponge. Treated surfaces must remain wet for 10 minutes, then allow to air dry. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution after each use.
