Dear Mr. Marvy,

This correspondence is intended to correct the Agency comments associated with the stamped accepted label as referenced above. The Agency letter dated July 25, 2007 is now corrected by revising the "Whirlpool Pedicure Foot Spa Disinfection Directions" to reflect the following:

After using whirlpool foot spa, drain the water and thoroughly clean all hard, nonporous surfaces with soap or detergent. Refill the pedicure foot spa with fresh water, to just cover the intake valve. Add 2 ounces of this product for each gallon of water at this point. Briefly start the pump to circulate the solution. Turn off the pump. Wash the unit sides, seat of chair, and any/all related equipment with sponge, brush, or swab. Treated surfaces must remain wet for 10 minutes. After the unit has been thoroughly disinfected, drain the solution from the pedicure foot spa and rinse any/all cleaned surfaces with fresh water.

The following amendment submitted in connection with registration under FIFRA, as amended, is acceptable with the conditions listed below.

Addition of Foot Spa Directions

Conditions

Revise the label as follows:

1. Remove the parentheses from around "foot spas" in the phrase "whirlpool foot spa units."

2. Delete the paragraph after "Special Instructions for cleaning and decontamination against HIV on surfaces/Objects soiled with blood/body fluids," because it is redundant.

3. Under the "Precautionary Statements" revise the "Wash thoroughly...after handling" statement to be in agreement with the Label Manual, 3rd edition by stating "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco."

3. Revise the "Whirlpool Foot Spa" directions to state "After using whirlpool foot spa, drain the water and thoroughly clean all hard, nonporous surfaces with soap or detergent. Rinse with water. Saturate surfaces with 2 oz of product per gallon of water to exposed surfaces with cloth, sponge, or sprayer. Brush or swab thoroughly and allow solution to stand for 10 minutes. After unit has been thoroughly disinfected, rinse all cleaned surfaces with fresh water."
