**DISINFECTION:** Preclean all surfaces prior to disinfection. Apply use solution, 4 1/2 ounces per gallon of water, thoroughly wetting surfaces with a cloth, mop, or sponge. Treated surfaces must remain wet for 10 minutes. All surfaces to air dry. Fresh solution should be prepared daily and more often if solution becomes diluted or soiled.

FOR LIGHT CLEANING AND DEODORIZING: Use 2 ounces Heavy Duty Cleaner & Disinfectant per gallon of water and follow the same procedure as for disinfecting.
