QUICK KNOCKDOWN THERMAL FOGGING INSECTICIDE

APPLICATION DIRECTIONS

DO NOT DILUTE — USE AS IT COMES FROM THE CONTAINER

For more effectiveness:

- 1. Treat shrubbery and vegetation where mosquitoes may rest. Shrubbery and vegetation around stagnant pools, marshy areas, ponds and shore lines may be treated. Application of this product to any body of water is prohibited.
- 2. Fog only after sunset in the evening, during the night, and before sunrise in the morning.
- 3. Wind velocity should not exceed 5 mph.
- 4. Area to be fogged should always be downwind from the fogging unit.
- 5. Fog should be released at the rate of 8 gallons per lineal mile, i.e., if truck travels 5 mph, the fogging insecticide flow rate should be 40 gallons per hour. This results in an average dosage rate of 0.10 gal, of HANDY FOG containing 0.13 pounds of Malathion per acre for an effective swath width of 660 feet.

IMPORTANT:

For mosquitoes allow ample fogging time for each area so that the fog remains in the area a minimum of 10 seconds. For flies allow ample fogging time so that fog remains in area a minimum of 40 to 50 seconds.
