Precautionary Statements

HAZARDS TO HUMANS (AND DOMESTIC ANIMALS)

Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing spray mist. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, aquatic organisms and aquatic life stages of amphibians. Do not apply directly to water except as specified on this label. MOSQUITO CONTROL IN POPULATED AND RURAL AREAS

GROUND APPLICATION

OUTDOORS - Mosquitoes and Small Fiving Insects - Use 2% MALATHION E-5 fog, aerosol or space spray. Dilute MALATHION E-5 1 to 28 parts with water, fuel oil, diesel oil, mineral oil, other suitable solvent for 2% spray. Treat shrubbery and vegetation where mosquitoes may rest. Shrubbery and vegetation around stagnant pools, marshy areas, ponds, and shore lines may be treated. Repeat applications as necessary. Avoid applying oil based spray to ornamental plants.

Nonthermal Aerosols-Undiluted:

Over a 300-foot swath can be produced using the nonthermal ultra low volume aerosol method with MALATHION E-5. Use the following rates at the indicated vehicle speeds:

Vehicle Speed Miles per Hour	Flow Rate of MALATHION E-5 Fluid Ounces per Minute	Maximum Flow Rete per Hour
5	1.8 to 4 fluid ounces	1.9 gallon
10	3.7 to 8 fluid ounces	3.7 gallons

20	7.4 to 16 fluid ounces	6.5 gallons

AERIAL APPLICATION

MALATHION E-5 may be applied aerially by suitable ULV equipment at a rate of 4.15 to 4.80 fluid ounces per acre. It may also be applied by diluting in water at a rate of to 4.8 fluid ounces of MALATHION E-5 per acre. Dilute the MALATHION E-5 in sufficient water or a suitable oil to give good coverage. Repeat application as necessary.

STORAGE & DISPOSAL

DO NOT STORE IN ANY PREMISE OCCUPIED BY HUMANS OR ANIMALS.

Do not contaminate water, food or feed by storage or disposal.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
