CAUTION

CAUTION: May be harmful if swallowed or inhaled. Do not take internally. Avoid contact with eyes, skin and clothing. Wash thoroughly after handling. Wash contaminated clothing before re-use. Do not enter or allow others to enter, including children and pests, until this material is washed into the soil and grass is dry. Keep away from food, feed stuffs and domestic water supply.

FIRST AID

If Swallowed: Call a physician or Poison Control Center.

If on Skin: Wash thoroughly with soap and water.

If in Eyes: Flush with plenty of water. Get medical attention if irritation persists. Avoid breathing of dust.

If inhaled: Get exposed person to fresh air. Keep warm. Make sure person can breathe freely. If breathing has stopped, give artificial respiration by arm lift method, not mouth-to-mouth resuscitation. Do not give anything by mouth to an unconscious person.

Note to Physician: Chlorpyrifos is a cholinesterase inhibitor. Atropine by injection is antidotal only if symptoms of cholinesterase inhibition are present. 2-PAM is also antidotal when given in conjunction with atropine.

ENVIRONMENTAL HAZARDS

This pesticide is extremely toxic to fish, birds and other wildlife. Do not apply directly to water. Drift and runoff from treated areas may be hazardous to aquatic organisms in adjacent aquatic sites. Cover or incorporate spills. Do not contaminate water by cleaning of equipment or disposal of water.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its' labeling.

METHODS and RATES to USE

Apply DURSBAN® 1%G granular insecticide uniformly to turf grass areas of golf courses using any hand or power operated gravity or rotary type spreader designed for application of granular materials. Treat when insects first appear using DURSBAN® 1%G at the rate of 100 pounds per acre. This rate is equivalent to a maximum application rate of 1 pound a.i. per acre. To help obtain uniform distribution, apply one-half the required amount of product in one direction, then apply the balance at a right angle. Immediately after application sprinkle the turf with 1300-gallons of water per acre so as to wash the granules into the zone of insect infestation. Consult the following table to determine amounts of DURSBAN® 1%G and water needed for smaller sized areas. Re-treat as necessary.
