The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the Permethrin and Piperonyl Butoxide RED(s), and has concluded that your submission is acceptable.

NOTE: This product is **not** being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on <u>non-refillable</u> containers. The code may appear either on the label or durably marked on the container itself, and can be added by non-notification per PRN 98-10.

Please note that the record for this product currently contains the Confidential Statements of Formulation (CSFs) listed below. Any previously dated CSFs are superseded.

## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION. Harmful if swallowed. Harmful if absorbed through skin. Avoid contact with eyes or clothing.

<u>Personal Protective Equipment (PPE)</u>: Some materials that are chemical-resistant to this product are: barrier laminate, nitrile rubber, neoprene rubber, or viton. Mixers, loaders, applicators, and other handlers must wear long-sleeve shirt and long pants, shoes plus socks. In addition, all handlers except for applicators using motorized ground equipment, pilots and flaggers, must wear chemical-resistant gloves. In addition, mixers/loaders, persons cleaning equipment, and other persons exposed to the concentrate must wear a chemical-resistant apron. See engineering controls for additional requirements.

Not for use in metered release systems. Not for use in outdoor residential misting systems. Do not contaminate crop land (other than crops listed), or potable water supplies with spray drift. Do not make applications during rain.

### **USE INFORMATION**

BIOMIST® 1.5+7.5 ULV is approved for application as an ultra low volume (ULV) nonthermal aerosol (cold fog) to control adult mosquitoes in residential and recreational areas and other areas these insects occur, such as but not limited to parks, campsites, woodlands, athletic fields, golf courses, residential areas and municipalities, gardens, playgrounds, and overgrown waste areas.

BIOMIST® 1.5+7.5 ULV can be applied over specific growing crops and range grasses prior to harvest for the control of adult mosquitoes within or adjacent to these areas. Application can be made where the following crops are present:

In the treatment of corrals, feedlots, swine lots, poultry ranges and zoos cover any exposed drinking water, drinking fountains and animal feed before application.

For best results treat when mosquitoes are most active and weather conditions are conducive to keeping the spray cloud close to the ground. An inversion of air temperatures and a light breeze is preferable. Application in calm air conditions is to be avoided. Apply only when wind speed is greater than 1 mph. Air temperature should be greater than 50 °F when conducting all types of applications.

Do not retreat a site more than once in 3 days. Do not exceed 25 applications at maximum labeled rate (0.005 lbs permethrin/0.025 lbs piperonyl butoxide [PBO] per acre) at any site in one year. When targeting *Aedes taeniorhyncus* and other difficult species, applications may be made up to 0.007 lbs permethrin and 0.035 lbs piperonyl butoxide [PBO] (8.2 fl. oz Biomist 1.5+7.5ULV) per acre. Do not exceed 0.18 lbs of permethrin or 0.90 lbs piperonyl butoxide [PBO] per acre per site per year. More frequent applications may be made to prevent or control a threat to public and/or animal health determined by a state, tribal, or local health or vector control agency on the basis of documented evidence of disease causing agents in vector mosquitoes or the occurrence of mosquitoborne disease in animal or human populations, or if specifically approved by the state or tribe during a natural disaster recovery effort.

## SPRAY DROPLET SIZE DETERMINATION

**Ground-based Application:** Spray equipment must be adjusted so that the volume median diameter (VMD) is less than 30 microns (Dv 0.5 < 30 um) and that 90% of the spray is contained in droplets smaller than 50 microns (Dv 0.9 < 50 um). Directions from the equipment manufacturer or vendor, pesticide registrant, or a test facility using a laser-based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

Aerial Application made at or below 200 feet above ground elevation: Spray equipment must be adjusted so that the volume median diameter produced is less than 60 microns (Dv 0.5 < 60 um) and that 90% of the spray is contained in droplets smaller than 100 microns (Dv 0.9 < 100 um). The effects of flight speed and, for non-rotary nozzles, nozzle angle on the droplet size spectrum must be considered. Directions from the equipment manufacturer or vendor, pesticide registrant, or a test facility using a wind tunnel and laser-based measurement instrument must be

used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

Aerial Application made at greater than 200 feet above ground elevation: Spray equipment must be adjusted so that the volume median diameter produced is less than 70 microns (Dv 0.5 < 70 um) and that 90% of the spray is contained in droplets smaller than 145 microns (Dv 0.9 < 145 um). The effects of flight speed and, for non-rotary nozzles, nozzle angle on the droplet size spectrum must be considered. Directions from the equipment manufacturer or vendor, pesticide registrant, or a test facility using a wind tunnel and laser-based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

#### GROUND ULV APPLICATION

Apply BIOMIST® 1.5+7.5 ULV through standard ULV cold aerosol or non-thermal aerosol (Cold Fog) generators undiluted at a flow rate of 6.0 to 48.0 fluid ounces per minute, and an average vehicle speed of 10 mph. If a different vehicle speed is used, adjust rate accordingly. These rates are equivalent to 0.00087 to 0.007 pounds of permethrin and 0.00437 to 0.035 pounds of piperonyl butoxide [PBO] per acre.

Vary flow rate according to vegetation density and mosquito population. Use higher flow rate in heavy vegetation or when populations are high.

## **AERIAL APPLICATION**

BIOMIST® 1.5+7.5 ULV may be applied undiluted at 2.0 to 5.8 fluid ounces BIOMIST® 1.5+7.5 ULV per acre by fixed wing or rotary aircraft equipped with suitable ULV application equipment. Do not apply by fixed wing aircraft at a height less than 100 feet, or by helicopter at a height less than 75 feet unless specifically approved by the state or tribe based on public health needs. Aerial applications shall only be made when recommended by public health officials and trained personnel of mosquito abatement districts and other mosquito control programs.

**IN FLORDIA:** Do not apply by aircraft unless approved by the Florida Department of Agriculture & Consumer Services.
