The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Permethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. #### Insecticide Resistance Management (IRM) Recommendations

For resistance management, BIOMIST® 30+30 ULV contains a Group 3A insecticide. Any insect population may contain individuals naturally resistant to BIOMIST® 30+30 ULV and other Group 3A insecticides. The resistant individuals may dominate the insect population if this group of insecticides are used repeatedly in the same area. Appropriate resistance-management strategies should be followed.

To delay insecticide resistance, take the following steps:

• Rotate the use of BIOMIST® 30+30 ULV or other Group 3A insecticides with other labeled effective mosquito adulticides that have a different mode of action.

- Adopt an integrated pest management program for insecticide use that includes surveillance, uses
  historical information related to pesticide use, record keeping, and which considers biological and other
  chemical control practices.
- Monitor after application for unexpected target pest survival. If the level of survival suggests the presence of resistance, contact your local university specialist or Clarke representative.
- Contact your local extension specialist, technical advisor, and/or Clarke representative for any additional

#### MANDATORY SPRAY DRIFT MANAGEMENT

#### **Ultra Low Volume Applications**

- Apply when ground wind speeds are equal to or greater than 1 mph.
- All types of applications should be conducted when temperatures at ground level are at or above 50°F.

#### For Ground Applications:

- Create an optimum swath when possible. An optimum swath width can be achieved when BIOMIST® 30+30 ULV is applied from a truck that is being driven perpendicular to the wind direction. Direct the spray head of equipment to ensure even distribution of the spray cloud throughout the area.
- FOR BEST RESULTS treat when mosquitoes or other labeled insects are most active and weather conditions are conducive to keeping the spray cloud in the air column close to the ground.
- An inversion of air temperatures and a light breeze is preferable. Application during the cooler hours of the night or early morning is recommended.

#### For Aerial Applications:

• Do not apply by fixed wing aircraft at a nozzle height less than 100 feet (30.5 m) above ground or canopy, or by helicopter at a height less than 75 feet (22.9 m) above the ground or canopy, unless specifically approved by the state or tribe based on public health needs.

Adult mosquito control applications should be limited to trained personnel.

- For use only by federal, state, tribal, or local government officials responsible for public health or vector control or by persons certified in the appropriate category or otherwise authorized by the state or tribal lead pesticide regulatory agency to perform adult mosquito control applications, or by persons under their supervision, or as allowed by state regulations for persons treating private property.

#### **USE INFORMATION**

BIOMIST® 30+30 ULV is approved for applications as a thermal aerosol and an ultra low volume (ULV) nonthermal aerosol (cold fog) to control adult mosquitoes in residential and recreational areas and other areas these insects occur, such as but not limited to parks, campsites, woodlands, athletic fields, golf courses, residential areas and municipalities, gardens, playgrounds, and overgrown waste areas.

BIOMIST® 30+30 ULV can be applied over specific growing crops and range grasses prior to harvest for the control of adult mosquitoes within or adjacent to these areas. Application can be made where the following crops are present:

Alfalfa Corn, grain Onion, bulb Almond Corn, stover Peach Apple Corn, sweet, kernel + cob with Pepper, bell Artichoke husks removed Pistachio **Asparagus** Eggplant Potato Avocado Fruit, pome, group 11 Soybean, seed Broccoli Garlic Spinach **Brussels sprouts** Tomato Range grasses

Cabbage Horseradish Vegetable, cucurbit, group 9\*

Cauliflower Leaf petioles subgroup 4B Walnut
Celery Leafy greens subgroup 4A Watercress

Cherry Lettuce, head Corn, forage Mushroom

In the treatment of corrals, feedlots, swine lots, poultry ranges and zoos cover any exposed drinking water, drinking fountains and animal feed before application.

When rotating this product with other insecticides containing [piperonyl butoxide][PBO], do not exceed 2 lbs [piperonyl butoxide][PBO] per acre per site per year.

#### **SPRAY DROPLET SIZE DETERMINATION**

**Ground-based Application:** Spray equipment must be adjusted so that the volume median diameter (VMD) is less than 30 microns (Dv 0.5 < 30 um) and that 90% of the spray is contained in droplets smaller than 50 microns (Dv 0.9 < 50 um). Directions from the equipment manufacturer or vendor, pesticide registrant, or a test facility using a laser-based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

Aerial Application made at or below 200 feet above ground elevation: Spray equipment must be adjusted so that the volume median diameter produced is less than 60 microns (Dv 0.5 < 60 um) and that 90% of the spray is contained in droplets smaller than 100 microns (Dv 0.9 < 100 um). The effects of flight speed and, for non-rotary

nozzles, nozzle angle on the droplet size spectrum must be considered. Directions from the equipment manufacturer or vendor, pesticide registrant, or a test facility using a wind tunnel and laser-based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

Aerial Application made at greater than 200 feet above ground elevation: Spray equipment must be adjusted so that the volume median diameter produced is less than 70 microns (Dv 0.5 < 70 um) and that 90% of the spray is contained in droplets smaller than 145 microns (Dv 0.9 < 145 um). The effects of flight speed and, for non-rotary nozzles, nozzle angle on the droplet size spectrum must be considered. Directions from the equipment manufacturer or vendor, pesticide registrant, or a test facility using a wind tunnel and laser-based measurement instrument must be used to adjust equipment to produce acceptable droplet size spectra. Application equipment must be tested at least annually to confirm that pressure at the nozzle and nozzle flow rate(s) are properly calibrated.

#### **GROUND ULV APPLICATION**

Apply BIOMIST® 30+30 ULV through standard ULV cold aerosol or non-thermal aerosol (Cold Fog) generators undiluted at a flow rate of 0.5 to 2.2 fluid ounces per minute, and an average vehicle speed of 10 MPH. If a different vehicle speed is used, adjust rate accordingly. These rates are equivalent to 0.00175 to 0.007 pounds each of Permethrin and Piperonyl Butoxide [PBO] per acre. BIOMIST® 30+30 ULV may also be applied by diluting with a suitable solvent such as mineral oil and applying so as not to exceed 0.007 pounds Permethrin per acre. The following charts represent suggested dilution and application rates for ground ULV applications. If an alternate dilution rate is used, adjust flow rate accordingly.

Vary flow rate according to vegetation density and mosquito population. Use higher flow rate in heavy vegetation or when populations are high.

BIOMIST 30+30 ULV may be applied through truck-mounted thermal fogging equipment. Do not exceed the maximum rates listed above. To reduce oil requirement and sludge buildup in equipment, use a 60 - 100-second viscosity mineral "fog" oil or other fuel-type oil. Use a clean, well-maintained and properly calibrated fogger. Do not wet foliage since oil base formulations may be phytotoxic. For use with hand carried foggers, use same rates of active ingredient per acre and a swath width of 50 ft with a walking speed of 2 mph. Do NOT use hand carried thermal fogger for application in enclosed spaces. Fog downwind, with the wind at your back.

BIOMIST® 30+30 ULV may be applied undiluted at rates up to 0.36 fl. oz. BIOMIST® 30+30 ULV per acre by fixed wing or rotary aircraft equipped with suitable ULV application equipment. BIOMIST® 30+30 ULV may also be diluted with a suitable solvent such as mineral oil and applied by aerial ULV equipment so long as 0.007 pounds permethrin or piperonyl butoxide [PBO] per acre is not exceeded.
