The proposed amendments reflected in the labeling submitted with the application and resubmissions have been reviewed and are acceptable for registration under Section 3 of the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) as amended provided that you revise the proposed labeling to reflect the following comments:

- 1. Under "Direction for Use of Acclaim" in Tank Sixes" revise "Comment" secti ot all lists of products with which Acclaim IEC ay be mixed by changing the heading to "Acclaim IEC" and under this heading add: "Reter to the Acclaim IEC Herbicide Application Rate and Timing Recommendation Chart".
- 2. Under "Hand-held Sprayer Application for Spot Treatments" you give a range of dosages (0.34 0.53 fluid ounces per gallon of water). You must instruct as to when to use the low dosage and when to use the high dosage for this use-pattern.
- 3. "Notes" on page 8 should be revised to read: "Notes for Weed Control in Turfgrasses".
- 4. On page 13 revise the statement "Application of Acciain 18C herbicide on" to read "Applications of Acclaim 18C herbicide in the culture of the following ornamental plants will result in phy ottoxicity or "Acclaim 18C herbicide is toxic to the relieving procedure; junts:".

- 5. On page 19 under "rhizome Johnsongrass, repeat applications", give instructions as to when to use the range of dosages: 12 45 and 0.8 2.8.
- 6. On page 20, revise the heading "Notes" to specify what the notes are related to; e.g. Notes for Weed Control in Rights-of-Ways. Revise the table "Acclaim Use Rates per Acre" with information as to when to use the range of dosages claimed.
- 7. Submit five (5) printed copies of the final printed labeling before releasing the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, Section 69e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the labeling is encloseed for your records.

Do not mow treated areas for at least 24 hours to allow time for penetration and translocation into the grassy weeds. The effectiveness of Acclaim 1EC Herbicide is reduced when grass clippings interfere with thorough spray coverage of the target weeds.

Repeat Application Information

Repeat applications of Acclaim 1EC Herbicide may be required under the following conditions (refer to application rate and timing recommendation chart for dosages):

- (a) Continued grassy weed seed germination after the initial application.
- (b) When dense popu' ons of weeds prevent thorough spray coverage of the entire leaf surface of target weeds.
- (c) For supression of common Bermudagrass and rhizome Johnsongrass.

E. Liquid Fertilizers

Acclaim 1EC Herbicide may be tank mixed with liquid nitrogen fertilizers (up to one pound/1000 sq.ft.) and iron chelates.

- 1. Stunting and/or chlorosis may occur on succulent, rapidly growing Kentucky Bluegrass. Symptoms are temporary and will subside.
- 2. Adequate soil moisture will enhance the performance of Acclaim 1EC Herbicide. Avoid application of Acclaim 1EC Herbicide under DROUGHT STRESS conditions. Thorough irrigation one to two days before or within one day after application will be helpful under these conditions. Rainfall or irrigation within one hour of application may cause a reduction in grass control. Allow spray deposit to dry before irrigation.
- 3. Acclaim 1EC Herbicide may be applied at no more than 10 fl.oz./A on Kentucky bluegrass seedlings that have tillered and have been emerged for over one month. Temporary discoloration and stunting of bluegrass seedlings may occur at this timing. Seedlings will recover, however; and the final bluegrass stand will be improved due to reduced competition from the annual grassy weeds. Annual grassy weeds must be untillered at the time of application for adequate control. Do not reapply Acclaim 1EC Herbicide to previously treated seedling Kentucky bluegrass for at least two months. When utilizing Acclaim 1EC Herbicide at rates higher than 10 fl.oz./A, Kentucky bluegrass seedlings must be at least three growing months old. DO NOT apply Acclaim 1EC Herbicide to seedling fine-leaf fescue, tall fescue, or perennial ryegrass less than 4 weeks old.
- 4. Broadleaf herbicides such as 2,4-D or MCP may reduce the effectiveness of Acclaim 1EC Herbicide. Tank mixes with 2,4-D or MCP
 containing herbicides are most effective on untillered crabgrass.

DIRECTIONS FOR USE ON BENTGRASS TURF

Acclaim 1EC Herbicide may be applied only to the following established bentgrass varieties maintained at a minimum cutting height of at least 1/4": Penncross, Penneagle, Pennlinks, J.H. Bent, Southshore, SR 1020, Providence, Putter, Kingstown, Tracenta, Bardot, Egmont, Allure, Seaside, and Colonial. The turf should be established for at least one growing season before Acclaim 1EC Herbicide is applied. DO NOT apply to bentgrass putting greens.

To control crabgrass in bentgrass turf, apply 0.09 fluid ounces, 1000 sq. ft. (4 fl.oz./A). The Acclaim 1EC Herbicide applications should be made at a minimum of 21-day intervals beginning in the spring when annual grassy weeds first emerge and are not larger than 2 leaf. Repeat applications throughout the summer as new infestations of 1-2 leaf annual grassy weeds occur. DO NOT apply more than 10 applications per growing season. Delay repeat applications to bentgrass turf under stress conditions. Injury may occur when applied during or immediately following periods of prolonged cool and/or moist conditions. Tank mixing with micronutrient mixes containing nitrogen and iron may alleviate injury symptoms to bentgrass turf. DO NOT tank mix Acclaim 1EC Herbicide with other pesticides or fertilizers on bentgrass turf except those fungicides listed on this label. The use of a colorant or dye in the spray tank is recommended so that spray pattern overlapping can be avoided.
