The proposed amendment to the label and Confidential Statements Of Formula(CSFs) for the product cited above submitted in response to the DEET Re-registration Eligibility Document(RED) are acceptable subject to the comments listed below:

1) Change the Ingredient Statement to read:

ACTIVE INGREDIENT
DEET...... 98.88%
OTHER INGREDIENTS...... 1.12%

- 2) Change the signal word from "Caution" to "Warning".
- 3) Add a Precautionary Statement to read as follows:

Precautionary Statements

Hazards To Humans And Domestic Animals

Causes substantial but temporary eye injury. Harmful if swallowed or absorbed through the skin. Do not get in eyes or on clothing. Avoid contact with skin. Wash hands before

eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash clothing before reuse."

4) Change the First Aid section to read:

IF IN EYES:

- * Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- * Remove contact lenses, if present, after the first five minutes, then continue rinsing.
- * Call a poison control center or doctor for treatment advice.

IF SWALLOWED:

- * Call a poison control center or doctor immediately for treatment advice.
- * Have person sip a glass of water if able to swallow.
- * Do not induce vomiting unless told to by a poison control center or a doctor.
- * Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING:

- * Take off contaminated clothing.
- * Rinse skin immediately with plenty of water for 15-20 minutes.
- * Call a poison control center or doctor for treatment advice.
- 5) Add the following Note to Physician:

"Note to Physician: Probable mucosal damage may contraindicate the use of gastric lavage."

- 6) The misuse statement, "It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.", must be added directly below the directions for Use.
- 7) The statement, "Store in a cool, dry and ventilated place.", must be added under the Pesticide Storage Subheading.

This product is not being re-registered at this time. Efficacy data may be required. Once the efficacy guidelines are in place, you will be notified of any efficacy requirements.

A stamped copy of the amended label is enclosed for your records. Submit two copies of the final label before the product is released for shipment under this revised label.

The Confidential Statement Of Formula dated August 3, 2001 is acceptable and has been made a part of the file.
