**DIRECTIONS FOR USE**

**FOR GARDEN SOIL:** To control Wireworms, White Grubs, Japanese Beetle Grubs, Root Maggots on radishes, onions, cabbage, work into top 2-3 inches of soil when preparing seed beds. 1# treats 600-700 sq. ft.

**FOR LAWNS:** To control Cutworms, Earwigs, Mole Crickets, For White Grubs, Japanese Beetle Grubs, Sod Webworm (Lawn Moth), apply liberally at rate of 1# to 250-300 sq. ft. Water well with hose to get material in nests and living places. CAUTION: KEEP CHILDREN AND PETS OFF TREATED LAWNS UNTIL INSECTICIDE HAS BEEN WATERED INTO SOIL AND GRASS IS THOROUGHLY DRY.

**FOR FOLIAGE:** To control Grasshoppers, Thrips, Plant Bugs on flowers, shrubs and other ornamentals, dust directly on plant and insect. Repeat as necessary.

**IN GARDEN:** To control Cutworms, Earwigs, Mole Crickets, Sow Bugs, Millipedes, Slugs, Snails, Leaf Cutting Ants on flowers, shrubs, ornamentals, dust liberally on ground, around plants. Remains effective at least 10 days. Repeat as necessary. 1# treats 200-300 sq. ft.

**IN HOME:** As spot treatment to control Ants, Cockroaches, Water Bugs and Silverfish, apply in cracks, corners, behind baseboards, around window sills, sinks, pipes and other hiding places. For Carpet Beetles, dust carefully infested areas where insects rest, run or hide. Repeat as necessary. For Brown Dog Ticks, dust directly on sleeping quarters of pets and place fresh bedding.

RINSE EQUIPMENT AND CONTAINERS AND DISPOSE OF WASTE BY BURYING IN NON-CROP AREAS AWAY FROM WATER SUPPLIES. EMPTY BAGS SHOULD BE DISPOSED OF BY BURYING OR BURNING (KEEP AWAY FROM SMOKE).
