> o Provided that the registrant of the active ingredient in these products submits the required data to continue the registration of it (prodiamine) for the use-patterns claimed on the labels of the subject pesticide products.

If at any time during the time of these extensions, we are able to astablish that the required data to support the registration of the active ingredient are in this Agency's



files, we shall change these registrations to FIFRA section 3(c)(5) registrations. Failure of the registrant of the active ingredient to submit the required data may result in the suspension of the subject products.

The proposed labeling amendments to add landscape ornamentals as uses sited and other amendments for these products have been reviewed for each of the subject pesticide product registrations and are acceptable for registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended provided that you:

- Revise the expression of dosage in footnote 1, listed under the section entitled: "Weeds Controlled", by listing the dosages in a consistent order from low to high.
- 2. Submit one (1) printed copy of the final printed label before releasing the product for shipment under the enclosed stamped label.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA, Section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.


