

Control of Crabgrass, Preemergence and Early Postemergence Control

This product provides "preemergence" control of crabgrass (including the large, smooth, and southern species) when applied prior to the emergence of crabgrass from the ground in established lawns and ornamental turfs.

It can also provide "early postemergence" control of crabgrass during the early stages of crabgrass growth after the crabgrass has emerged from the ground. However, it is often difficult to see the very small, early stages of crabgrass in well-established lawns and ornamental turfs. Postemergence crabgrass control will be obtained only when this product is applied prior to the tillering of crabgrass, which generally corresponds to the time when you can first easily see the crabgrass plants in the lawn or turf. So the practical benefit of this product's additional, early postemergence activity is that (compared to strictly preemergence crabgrass products) it can give the user a 2-4 week longer period of time to make an application and still control crabgrass.

APPLICATION FREQUENCY AND TIMING

This product may be applied as a single application, as a split application, or as a sequential application for crabgrass control in the spring, summer, or fall.

<u>DO NOT apply more than 6.75 lbs. of this product per 1,000 sq. ft. per application, and no more than 10.1 lbs. of this product per 1,000 sq. ft.</u> per year.

Spring Applications

For single applications made in the spring or early summer, this product should be applied at the appropriate rate corresponding to one of the two control programs listed in Table 1 below, depending on the user's location, the turfgrass mowing height, and whether the use is considered to be preemergence or early postemergence at the time of application. The duration of residual weed control provided by this product is directly related to the total rate applied, but will vary somewhat depending on weather, weed pressure, turfgrass competitiveness, and the user's location within a region.

<u>Use Program #1</u> for preemergence control at sites where the turfgrass is cut high (e.g., homeowner lawns). This program provides 3-5 months of preemergence crabgrass control. This program should not be used for early postemergence crabgrass control.

Fall Applications

This product can also be applied in the late summer or early fall (late August through November) at the "Program 2" use rates listed in Table 1 to provide control of crabgrass through the early part of the next spring.
