#### **APPLICATION EQUIPMENT**

Apply Shaw's Turf Food with 0.067% Acelepryn Plus 0.222% Dimension with drep type-of rotary type equipment. The application equipment must be properly calibrated according to the manufacturer's confirmation coverage over the treated area. During application, check the equipment periodically to confirm that it is working properly and that the granules are being uniformly distributed. A more uniform application can be made by spreading one-half of the recommended amount of this product over the turfgrass area and then spreading the remaining one-half of this product at a right angle to the compression application direction.

#### **APPLICATION TIMING - INSECT CONTROL**

White Grubs: Apply this product from early April to early September for preventative and early cufative control of all of the major white grub species infesting turfgrass. Irrigate turf immediately after application.

Annual Bluegrass Wesvill: Apply this product when everwintered adult weevils are observed in late April or early. May to prevent damage from first generation larvae in late May and June. An application of this product at this time will also provide white grub control. The higher rates listed in Table 1-may be required for application made after mid-May.

**Billbugs:** Apply this product when overwintered adult billbugs are first observed. This will usually occur in late April or early May in regions with cool-season turfgrasses. An application of this product at this time will also provide white grub control. The higher rates listed in Table 1 may be required for applications made after early May or when billbug species other than bluegrass billbug are present.

**European Crane Fly:** Apply this product between September and November to control European crane fly larvae in turfgrass. The higher rate listed in Table 1 may be required to achieve control when applications are made in November.

Spittlebuge: This product will provide control of two lined spittlebug when applications are made in apring or summer!

**Turf Caterpillars:** This product will provide curative caterpillar control in turfgrass. If the area being treated is maintained at a mowing height of greater than one inch, the higher rate listed in Table 1 may be required during periods of high pest pressure.

Chinch Buge: For suppression of chinch bugs, apply this product before eggs hatch.

#### **APPLICATION TIMING - WEED CONTROL**

This product may be applied in the spring or fall prior to weed seed germination in established lawns and ornamental turfgrasses. This product provides preemergence control of crabgrass and other weeds when applied prior to their germination, and it may also provide postemergence control of seedling crabgrass.

**Postemergence Crabgrass Control:** The postemergence control provided by this product is limited to crabgrass, and it will only provide control up to 4 weeks after crabgrass germination, with best control expected when crabgrass is small (3-4 leaf stage). This product will not control large, tillered crabgrass. For control of other grasses and broadleaf weeds, this product must be applied as a preventative treatment before their emergence.

**Reseeding, Overseeding or Sprigging:** Reseeding, overseeding, or sprigging of turfgrasses listed on this label into areas that have been previously treated with this product must be delayed until 8 weeks after the previous application. Reseeding, overseeding, or sprigging before 8 weeks after application may injure or prevent the establishment of the newly reseeded, overseeded, or sprigged turfgrass.
