Dear Ms. Garvie:

This is a notification per your request to replace the asterisk following "Active Deodorizer" on the back of the label for 8383-3 Sporicidin Brand Disinfectant Solution. Per CDPR's request, we would also like to add the word "virus" after Avian Influenza A, Influenza  $A_2$ , Vaccinia, and Herpes simplex type 1/F and 2/G on both the 8383-3 and 8383-7 labels.

In a letter dated March 22, 2010, I sent a notification application to PM#34 for another change you will note on the 8383-3 label. Per CDPR's request, we are adding double asterisks following "Virucidal" on the front and back of the label.

Enclosed please find a copy of our recent e-mail correspondence concerning this matter, forms 8570-1, and copies of the labels with the most recent changes marked in red.

This notification is consistent with the guidance in PR Notice 98-10 and the requirements of EPA's regulations at 40 CFR §§ 156.10, 156.140, 156.144, 156.146, and 156.156. No other changes have been made to the labeling or the Confidential Statement of Formula for this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if the amended label is not consistent with the requirements of 40 CFR §§ 156.10, 156.140, 156.144, 156.146, and 156.156, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.

TO DISINFECT AND DEODORIZE Items which cannot be immersed, such as electrical panels, cash registers, door knobs, handles, seats, dashboards and other "high touch" surfaces in and around farm equipment, animal and poultry housing, barns, kennels, breeding pens, hatcheries, trucks and vehicles: Thoroughly wet pre-cleaned surface with
