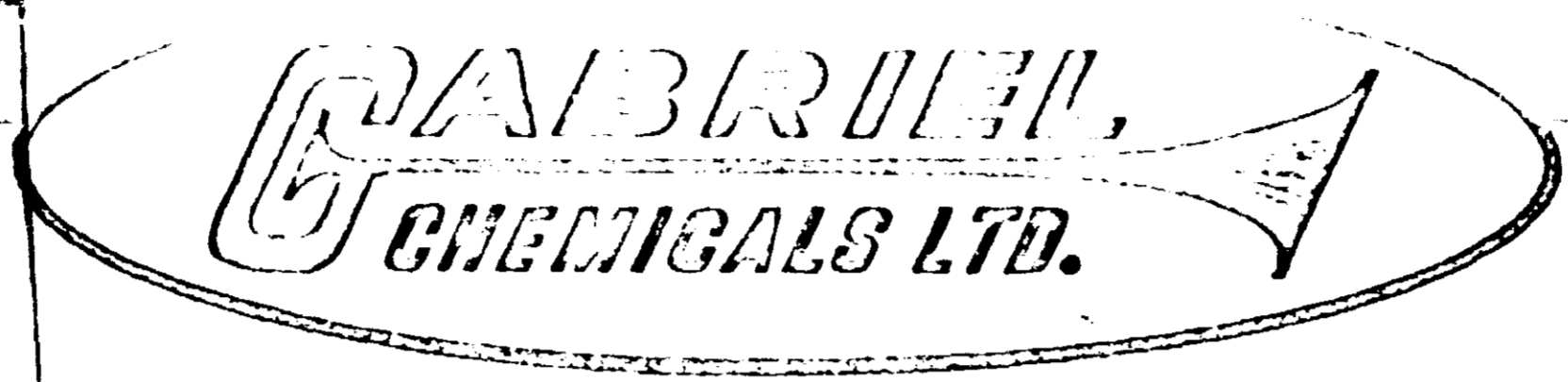

ANTIDOTE

INTERNAL: IF SWALLOWED INDUCE VOMITING IMMEDIATELY. THIS MAY BE DONE BY INTRODUCING A FINGER INTO THE THROAT OR BY GIVING A TABLESPOON OF SALT IN A GLASS OF WARM WATER. REPEAT UNTIL VOMIT FLUID IS CLEAR. HAVE VICTIM LIE DOWN AND KEEP WARM AND QUIET. NEVER GIVE ANYTHING BY MOUTH TO UNCONCIOUS PERSON. CALL A PHYSICIAN IMMEDIATELY! NOTE TO PHYSICIAN: ATROPINE IS ANTIDOTAL FOR THIS PRODUCT.

EXTERNAL: IF MATERIAL HAS BEEN SPILLED ON SKIN IMMEDIATELY REMOVE PATIENT FROM VICINITY OF INSECTICIDE. REMOVE ALL CONTAMINATED CLOTHING AND WASH SKIN WITH SOAP AND WATER. IF MATERIAL GETS INTO EYES WASH IMMEDIATELY WITH RUNNING WATER FOR AT LEAST 10 MINUTES.

DISPOSAL OF EMPTY CONTAINERS

Do not re-use container. Completely empty contents and bury unused chemical at least 18 inches deep in isolated location away from water supplies. Punch holes in TOP of container and burn in hot fire until all the paint has been completely burned off the container. Extreme caution should be exercised to insure that containers are completely empty and that persons stay away from smoke and fumes. Do not attempt to burn more than 5 containers at one time.
