

**PRECAUTIONARY STATEMENTS: HAZARDS TO HUMANS AND DOMESTIC ANIMALS.**

In case of decomposition, isolate container, if possible, and flood with large amounts of water to dissolve all materials before discarding. Do not re-use empty container. Securely wrap original container in several layers of newspapers and discard in trash. Do not contaminate water, food, or feed by storage or disposal.

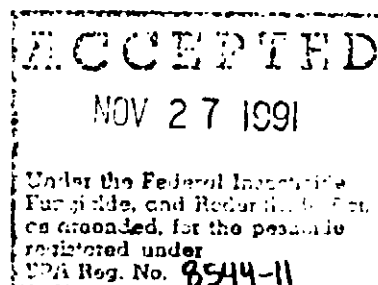
**INSTRUCTIONS:** Before application turn off filter pump. Vigorously brush algae spots with a stainless steel brush. Sprinkle SANI-CLOR Good-Bye Algae directly over surfaces on which algae appears. Use one (1) pound per 10,000 gallons of water. For severe cases double the dosage. Leave SANI-CLOR Good-Bye Algae in your pool 24 to 36 hours before turning on filter pump.
