

PRECAUTIONARY STATEMENTS: HAZARDS TO HUMANS AND DOMESTIC ANIMALS.

DANGER: Highly corrosive. Causes skin and eye damage. May be fatal if swallowed. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Irritating to nose and throat. Avoid breathing dust. Remove and wash contaminated clothing before reuse.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not discharge into lakes, streams, ponds or public waters unless in accordance with an NPDES Permit. For guidance contact the regional office of the EPA.

PHYSICAL AND CHEMICAL HAZARDS STRONG OXIDIZING AGENT: Mix only with water. Use clean, dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire or explosion. Contamination with moisture, organic matter or other chemicals may start a chemical reaction, with generation of heat, liberation of hazardous gases and possible generation of fire and explosion. In case of contamination or decomposition, do not reseal container. If possible isolate container in open air or well-ventilated area. Flood with large volumes of water if necessary.

STORAGE AND DISPOSAL: Keep product dry in a tightly closed container when not in use. Store in a cool, dry, well-ventilated area away from heat or open flame. In case of decomposition, isolate container, if possible, and flood with large amounts of water to dissolve all materials before discarding. Do not reuse empty container. Securely wrap original container in several layers of newspapers and discard in trash. Do not contaminate water, food, or feed by storage or disposal.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

INSTRUCTIONS: Stabilize pool with SANI-CLOR Conditioner. If pool is already stabilized, do not add conditioner. Initially treat pool with SANI-CLOR liquid sanitizer or SANI-CLOR Granules, as per label instructions until chlorine reaches 1.0 to 1.5 ppm on a SANI-TEST Kit. Add small tablets to a floating dispenser at the rate of one tablet per 2000 gallons of water. Add additional tablets every other day to maintain the chlorine level at 1.0 to 1.5 ppm. For comfort and effective pool care, maintain pH between 7.2 and 7.8. Test pool water frequently with a SANI-TEST Kit.

PRACTICAL TREATMENT (FIRST AID):

IF SWALLOWED: Promptly drink large quantities of water. DO NOT induce vomiting. Call physician immediately. **IF ON SKIN:** Brush off excess dry chemical, flush skin with cold water for at least 15 minutes. If irritation persists, obtain medical attention. **IF IN EYES:** Flush with cold water for at least 15 minutes. Obtain medical attention.
