

**PRECAUTIONARY STATEMENTS: HAZARDS TO HUMANS AND DOMESTIC ANIMALS.**

**PHYSICAL AND CHEMICAL HAZARDS STRONG**

**OXIDIZING AGENT:** Mix only with water. Use clean, dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire or explosion. Contamination with moisture, organic matter or other chemicals may start a chemical reaction, with generation of heat, liberation of hazardous gases and possible generation of fire and explosion. In case of contamination or decomposition, do not reseal container. If possible isolate container in open air or well-ventilated area. Flood with large volumes of water if necessary.

**STORAGE AND DISPOSAL:** Keep product dry in a tightly closed container when not in use. Store in a cool, dry, well-ventilated area away from heat or open flame. In case of decomposition, isolate container, if possible, and flood with large amounts of water to dissolve all materials before discarding. Do not re-use empty container. Securely wrap original container in several layers of newspapers and discard in trash. Do not contaminate water, food, or feed by storage or disposal.

**INSTRUCTIONS:** Stabilize pool with SANI-CLOR Conditioner. If pool is already stabilized, do not add conditioner. Initially treat pool with SANI-CLOR Liquid Sanitizer or SANI-CLOR Granules 2 as per label instructions until chlorine level reaches 1.0 to 1.5 ppm on the SANI-TEST Kit. After initial chlorination, add one (1) tablet into a floating dispenser per 10,000 gallons of water daily or as needed. For comfort and effective pool care, maintain pH between 7.2 and 7.8. Test pool water frequently with a SANI-TEST chlorine test kit. It will not be necessary to stabilize again as tablets are self stabilizing.

**PRACTICAL TREATMENT (FIRST AID):**

**IF SWALLOWED:** Promptly drink large quantities of water. DO NOT induce vomiting. Call physician immediately. **IF ON SKIN:** Brush off excess dry chemical, flush skin with cold water for at least 15 minutes. If irritation persists, obtain medical attention. **IF IN EYES:** Flush with cold water for at least 15 minutes. Obtain medical attention.
