

Make application on warm, clear days when annual weeds are small or perennial weeds are just starting to grow. Do not mow grass two days before or following treatment.

At the above rate, some injury may occur to such tender species as clover, bent grass and St. Augustine grass. However, these species usually recover.

Do not spray newly seeded lawns. On new lawns, application can usually be applied after the second or third mowing without injury to grasses.

This herbicide will not usually control such hard-to-kill species as chickweed, crab grass or Veronica filiformis.

NOTE: This pesticide is to be sold ONLY in this original unopened package.

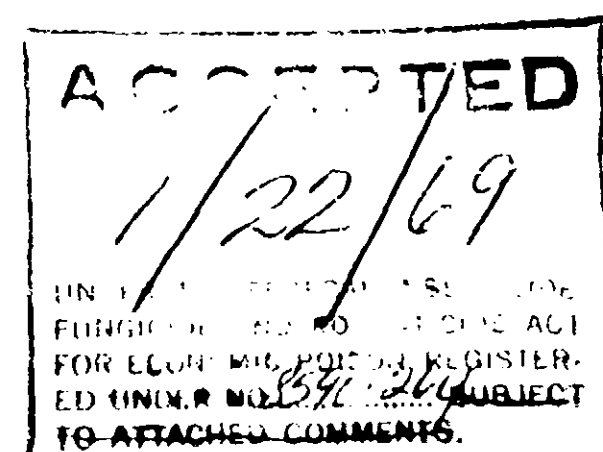
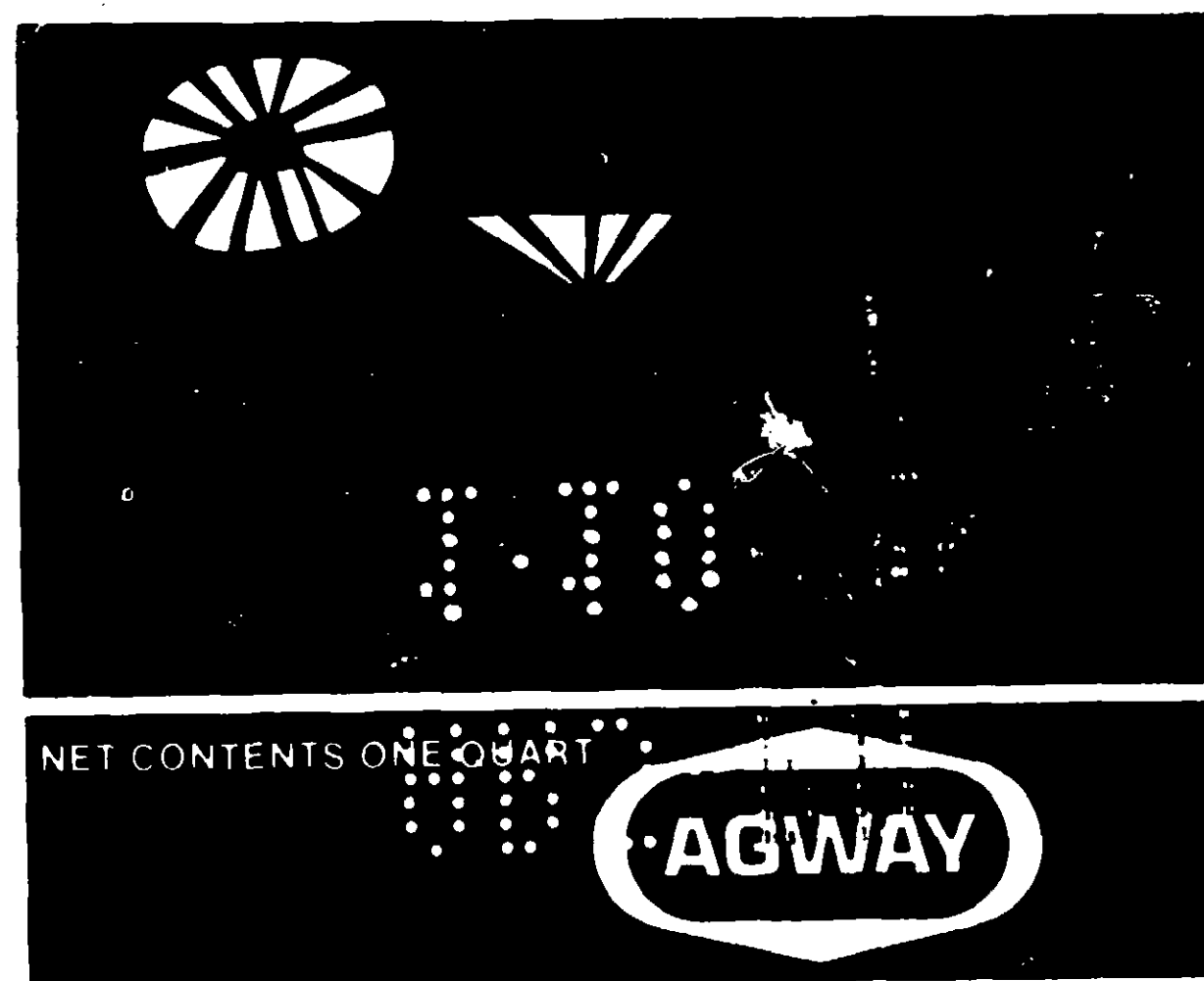

FOR LAWN AND TURF: For the control of such weeds as dandelion, ground ivy, ragweed, lambsquarters, pigweed, mustard, annual sow thistle, chicory, buckhorn and broadleaf plantain, use Agway, 2,4-D WEED KILLER at the rate of 5 teaspoonsful in 1 gallon of water to cover 1,000 square feet.
