Apply when first signs of feeding appear and repeat as needed. Do not apply to Broccoli and Cabbage within 7 days of harvest. Do not apply to Cauliflower within 14 days of harvest.

CUCUMBERS, MELONS, SUMMER & WINTER SQUASH: To control Aphids, use 25 to 30 lbs. per acre.

EGGPLANTS, PEPPERS, TOMATOES: To control Aphids, Colorado Potato Beetle, Flea Beetles, Green Stink Bug. use 15 to 20 lbs. per acre. Use the higher rate for large mature plants. Do not apply within 1 day of harvest on Peppers and Tomatoes. Do not apply within 1 day of harvest on Eggplant at the rate of 15 lbs. per acre.

ORNAMENTALS: To control Aphids, dust lightly but uniformly. On Chrysanthemums, best results will be obtained if applied before plants flower. Do not use on birch trees.

POTATOES: To control Aphids, Colorado Potato Beetle, Flea Beetle, Green Stink Bug. Plant Bugs, Leafhoppers, Southern Armyworm, use 30 to 35 lbs. per acre.

Do not plant root crops other than carrots, sweet potatoes or sugar deeds as follow-up crops.

TOBACCO: To control Cabbage looper, Green peach aphids, tobacco budworm, tobacco flea beetle and tobacco hornworm. In seedbeds: apply 2 lbs. Thiodan 3D per 100 sq. yards or in field treatments; apply 20 to 35 lbs. Thiodan 3D per acre.
