Repeat at 7 to 10 day intervals as necessary. SOIL AND GREENHOUSE BENCH TREATMENT: Preplanting for Dampoff and Root-Rot Diseases on Seedling or Transplants of Roses (and other shrubs and trees) Many flowers, cucumbers & cantaloupes and lawn seedbeds - 14 to 24 lbs per 1000 sq. ft. (50 to 60 lbs. per acre). Work into upper 3 or 4 inches of soil before planting. Only the applicator is permitted to be in the greenhouse during application of captan Open vents to greenhouse during application and for at least 1 hour after application. PEACE, NECTARINES: Brown Rot and Peach Scab. 50 lbs. per acre. Make 2 to 3 pre-bloom applications. Repeat at petal fall and 3 to 4 covers as necessary. Make pre-harvest application where necessary. May cause slight injury on some varieties in the later sprays.

CHERRIES: To control leaf spot and brown rot, apply 35 to 40 lbs. per acre. On sweet cherries, apply in pink, bloom, and subsequent sprays, at 10 day intervals or less. On sour cherries, begin applications at petal-fall. Under severe infection conditions, shorten the interval between applications.

STRAWBERRIES: To control Botrytis fruit rot, apply 30 to 40 lbs. per acre, beginning when new growth starts and repeat at 6 to 10 day intervals Use shorter intervals under conditions favorable to infection. Continue applications up to 3 days before first picking and treat immediately after each picking.
