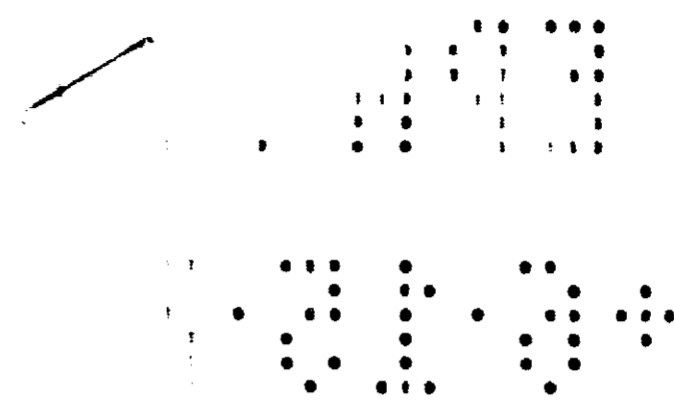

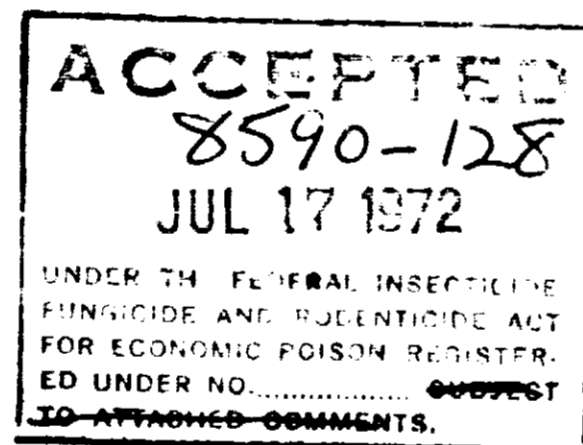

## DIRECTIONS

**READ THESE ENTIRE DIRECTIONS AND WARRANTY OF SALE. USE STRICTLY IN ACCORDANCE WITH LABEL CAUTIONS, WARNINGS AND DIRECTIONS.**

APPLES, APRICOTS, CHERRIES, NECTARINES, PEACHES, PLUMS, PRUNES, PEARS: *Pre-Bloom* for control of mites and mite eggs. Apply 30 to 50 lbs. per acre in pre-bloom period (delayed dormant, pre-pink or pink). Do not apply after first bloom.

APPLES, PEARS: *Post-Bloom* for control of mites and mite eggs. Apply 30 to 50 lbs. per acre. Repeat as necessary but NOT MORE THAN 3 TIMES PER SEASON. Do not apply within 35 days of harvest. Foliage and fruit injury may occur in some locations, under certain conditions (particularly Anjaw variety from summer applications). Do not graze treated areas.

NOTE: This pesticide is to be sold ONLY in the original unbroken package.
