A fungicide, insecticide dust mixture for controlling certain diseases and insects affecting potatoes. This dust mixture contains Parathion which is not stable as a dust and should be used within one growing season.

POTATOES: For control of Early and Late Blight, Aphids, Blister Beetles, Leaf Hoppers and Thrips. Apply 30 to 40 lbs. per acre. Make the first application when conditions are favorable to the development of disease or when insects are first noted and repeat at 7 to 10 day intervals as necessary. Consult your State Agricultural Extension Service for recommendations under unusual conditions. Do not apply to potatoes within 5 days of harvest.
