

LAWNS. OR AMENIAL THE NUFSERY SOILS: To control such subsoil insects as wireworms, and grubs of Japanese beetle, European chafer, Asiatic garden beetle, masked chafer, May beetle, Oriental deetle and rose chafer, apply 11 teappoins of in 5 gardens of water to 500 sq. ft. Apply when infestation is discovered and ground is not frozen. Thoroughly mix into top 3 inches of soil by harrowing, or wash in by sprinkling. One application should provide protection against the above grubs for 1 or more years and will also control ants, chiegers, chinch bugs, cutworms, earwigs, millipedes, mole crickets, sod webworms and sowbugs when present. Keep children and pets off treated area until insecticide is washed into the soil and the grass is thoroughly dry.

Moles will tend to leave lawns after insects serving as a food supply have been controlled.

1995 to the party of the Use 1 quart of Chlordane per 50 gallons of water (4 teaspoonsful/gallon). Dig a 1 foot x 1 foot trench along exterior of foundation. Treat both trench and back fill. Apply 1/2 gallon of spray per linear foot of trench.

For deep foundations bore 1 inch holes 8 inches apart and 15 inches deep in the bottom of the trench. (Do not dig below the depth of footings.) Spray trench and back fill with 1 gallon of above spray per linear foot of trench.

Saturate unexposed soil areas under patios and walks adjacent to the foundation with the above spray. Pour in expansion cracks and in shallow trenches or holes bored 12 inches apart along walk edge

Treat exposed soil under porches with 1 gallon of same spray per square yard or per 10 square feet. In heavy clay soils increase the mixture to 1 quart of Chlordane per 50 gallons of water (8 teaspoonsful/gallon). Spray thoroughly all areas where wood contacts soil as well as points of entry around basement windows and pipes. Use 2 quarts per 50 gallons of spray (8 teaspoonsful/gallon).

Inspect annually to determine the need for reapplication.
