GENERAL INFORMATION: Lawn Shield containing Tupersan "Siduron" has the following advantages:

- 1 PERMITS SEEDING AND TREATING FOR CRABGRASS THE SAME DAY.
- 2 FULL SEASON CRABGRASS PROTECTION FOR ESTABLISHED LAWNS AND TURF AREAS
- 3. MAY BE USED UNDER TREES AND SHRUBS IN TURF AREAS.
- 4 PREVENTS ANNUAL WEEDS SUCH AS FOXTAIL AND BARNYARDGRASS FROM BECOMING ESTABLISHED.

Lawn Shield contains Tupersan "Siduron", which is highly effective for the control of Smooth and Hairy Crabgrass Foxtail and Barnyardgrass in newly seeded or established plantings of the following turf grasses: Bluegrass, Fescue Redtop, Smooth Brome, Perennial rivegrass. Orchardgrass, and the following strains of Bentgrass: Penncross, Seaside, Highland, Astoria Nimistia C-1, C-7 and C-19. Do not use on other Bentgrass strains nor on Bermudagrass, as injury to turf may result. Apply on a calm day to avoid wind drift.

### ESTABLISHED LAWNS. GOLF COURSES AND RECREATIONAL AREAS:

WHEN TO APPLY: On any non-cropped area where Crabgrass control is desirable; for best results apply early Spring when Forsythia is in full bloom, but before emergence of Crabgrass or other weeds to be controlled.

HOW MUCH TO APPLY: Apply contents of bag (7.5 lbs.) evenly to 2,000 square feet (an area 50' x 40'). Use any lawn spreader in good condition. Do not spread over larger area than recommended as such an application would give poor results.

HOW TO APPLY: Before applying rake lawn to remove extraneous material. To insure even and uniform coverage, it is suggested that the area be covered twice (using one-half dosage rate each time). The second time, if possible, at right angles to the first. Do not rake the lawn or disturb soil after application. For best results apply water to thoroughly wet soil to a depth of 2 to 3 inches if no rain falls within three days of application.





#### NEWLY SEEDED LAWNS, GOLF COURSES AND RECREATIONAL AREAS:


HOW MUCH TO APPLY: Apply the contents of bag (7.5 lbs.) evenly to 4,0 $^{\circ}$ 0 square feet (an area 50' x 80'). To insure full season control, it will be necessary to repeat newly seeded areas at the above rates in 4 weeks.

OVERSEEDED LAWN AND TURF AREAS: Fall overseeding on established lawn and turf areas is preferred. On Fall overseeded areas, use Lawn Shield at rates outlined in preceding paragraph. Spring overseeding on established lawn and turf areas can be treated at rates outlined in preceding paragraph.

HOW TO APPLY: Prepare ground and seed desirable grasses such as K-ntucky or Merion Bluegrass, Bents, Fescue, Redtop and Perennial Ryegrass in the usual manner. Apply Lawn Shield immediately after seeding at the rate mentioned per 4000 sg are feet. NOTE: A watering program on any newly seeded or overseeded area is desira le and will insure uniform germination of desirable grasses and will also insure the pe formance of Lawn Shield.
