APPLES: For Control of Apple Scab: For control of apple scab apply 2 lbs. per 500 gals. of spray. Begin applications at silver or green tip if a scab rain period is predicted. Apply before scab infection occurs.

Repeat as needed to keep new foliage protected with fungicides through primary scab infection period. Use 2 lbs. per 500 gals. of spray in all remaining cover sprays as required

Do not apply within 7 days of harvest. Treated apples should not be used in the manufactured apple pomace for use in livestock feeds.

Sour Cherry: For control of Leaf Spot, apply 2 lbs. per 500 gals. of spray. Begin applications at petal fall (or when first leaves unfold) and repeat at 7 to 10 day intervals as needed. **CAUTION: TO AVOID ILLEGAL RESIDUES, DO NOT APPLY WITHIN 7 DAYS OF HARVEST.** Apply one or more sprays after harvest as needed.

Glyodex is compatible with most commonly used wettable powder forms of insecticides, acaricides and fungicides. Do not use with lime or chlorobenzilate. Do not use on Golden Delicious.
