This dust is suitable for application by ground duster or airplane. For Airplane Application, use heavier dosages. Begin applications at first sign of insects. Repeat as necessary. Apply for contact and thorough coverage to obtain control of insects listed on the label. Do not apply to food or forage crops within 4 days of harvest unless otherwise specified.

BEANS (Dry or Field): Aphids, Red Spider Mites, Lygus Bugs—50 lbs. per acre. Repeat as necessary with thorough coverage. Do not apply within 4 days of harvest.

BROCCOLI, CABBAGE, CAULIFLOWER, COLLARDS, BRUSSELS SPROUTS, KALE, TURNIPS: Cabbage Looper, Imported Cabbageworm, Diamond-Back Caterpillar, Aphids. Do not apply within 1 day of harvest on Broccoli, Brussels Sprouts, Cabbage, Cauliflower and Turnips. Do not apply within 4 days of harvest on Collards and Kale.

GRAPES: Leafhoppers—40 to 50 lbs. per acre. Drosophila—50 lbs. per acre. Apply pre-harvest at first sign of drosophila or bunch rot. Repeat at weekly intervals as necessary to maintain control. Do not apply within 4 days of harvest.

HOPS: Aphids, Red Spider Mites — Use 25 lbs. per acre. Do not apply within 4 days of harvest.

LETTUCE, SPINACH, CELERY, CHARD: Looper Caterpillars, Aphids. Use 40-50 lbs. per acre. Do not apply on Chard, Lettuce and Spinach within 1 day of harvest. Do not apply on Celery within 4 days of harvest.

STRAWBERRIES: Red Spider Mites, Aphids. Use 40-50 lbs. per acre. Do not apply within 4 days of harvest.

TOMATOES: Tomato Fruitworms, Hornworms, Leafminers -40 to 50 lbs. per acre. Do not apply within 1 day of harvest.

TOMATOES (Field). Fruit Flies (Drosophila sp.) --25 lbs. per acre. Make first application at 5 to 7 days before first picking and continue at 5 to 7 day intervals until harvest is complete. Do not apply within 1 day of harvest.

APPLICATION

Ground Dusters on Bush Type Plants: Mount duster nozzles close to the ground, pushing dust upward and forward through the plants. Top nozzles alone are not acceptable on row crops. Use combination top and bottom delivery. Horizontal side delivery nozzles are not acceptable on crops such as grapes and hops.

Airplane Dusting: Avoid applications during periods of rising or high temperatures which create convection currents or thermal cushions near ground level.

Observe the following rules:

- 1. NEVER FLY SWATHS IN EXCESS OF 30-32 FEET.
- 2. ALWAYS FLY WITH ROWS—NEVER ACROSS, on row crops.
- 3. Fly at full speed to create maximum air turbulence, preferably 85-90 mph. NEVER FLY in TAIL DOWN, STALL ATTITUDE.
