## DIRECTIONS

READ THESE ENTIRE DIRECTIONS AND WARRANTY OF SALE. USE STRICTLY IN ACCORDANCE WITH LABEL CAUTIONS, WARNINGS AND DIRECTIONS.

Fentex 1% Granular is recommended for use wherever mosquitoes breed, except in water where shrimp, crabs or crayfish are of value. Fentex 1% Granular should not be used on food crops. Fentex 1% Granular provides long residual control and is effective against DDT-resistant as well as non-resistant strains.

**MOSQUITO CONTROL ON ALFALFA AND PASTURE GRASS:** Applications may be made at rates of 0.05 to 0.2 lb. active per acre. Fentex 1% Granular may be used once per cutting on alfalfa. Fentex 1% Granular may also be used up to 4 times per year on pasture grass without removal of grazing livestock.

For mosquito larvae control, applications should be made to moist areas, standing water, and around the edges of larger ponds, lakes, marshes, swamps, and tidal areas. Also apply around and on dumps, catch basins, and similar areas where mosquitoes breed.

### RECOMMENDED APPLICATIONS

Apply 5 to 20 lbs. of Fentex 1% Granular per acre uniformly to control Mosquito Larvae. Repeat as necessary except as indicated for use on alfalfa and pasture grass. Use the higher rate where pools of water are greater than one foot in depth.

**WARRANTY:** Seller warrants that the product conforms to its chemical description and is reasonably fit for the purpose stated on the label when used in accordance with directions under normal conditions of use, but neither this warranty nor any other warranty of merchantability or fitness for a particular purpose, express or implied, extends to the use of this product contrary to label instructions, or under abnormal conditions, or under conditions not reasonably foreseeable to seller, and buyer assumes the risk of any such use.
