

# METHOXYCHLOR M-2E

Emulsifiable Liquid—An Insecticide For Control Of Mosquitoes And Flies

(Contains 2 lbs. Technical Methoxychlor per Gallon in Hand)  
For Use As A Mosquito Larvicide in Mosquito Breeding Areas and As A Space Spray For Flies.

\*23.7% Methoxychlor, Technical is equivalent to 21% 2,2-bis(p-methoxyphenyl)-1,1,1-trichloroethane and 2.7% other isomers and reaction products.

## GENERAL INFORMATION

Methoxychlor M-2E is an emulsifiable insecticide containing 2 pounds technical methoxychlor per gallon and is to be used as a spray with water (forming a stable emulsion) for the control of certain insects. It is suitable for high or low volume application.

Methoxychlor M-2E should be used only in accordance with recommendations on this label. Consult your State Agricultural Experiment Station for additional information regarding the timing of application as this will vary with local conditions.

## DIRECTIONS FOR USE

**READ THESE ENTIRE DIRECTIONS AND WARRANTY OF SALE. USE STRICTLY IN ACCORDANCE WITH LABEL CAUTIONS, WARNINGS AND DIRECTIONS.**

**COMPATIBILITY**—Do not use this product with any spray materials which are incompatible with oil. Do not apply within 14 days of sulfur or sulfur-product applications.

**CONTACT AND SPACE SPRAY FOR FLIES**—To reduce population of houseflies, stable flies and mosquitoes in farm buildings, alleys, dumps, barnyards and other outdoor locations—dilute 1 pt. of Methoxychlor M-2E with 2½ gals. of water and apply in space by mist blower or directly to flies by hydraulic sprayer, hand sprayer or cylindrical pressure sprayer. Care should be taken to avoid contamination of milk handling equipment, feedstuffs, feed troughs and watering receptacles. Dairy animals should not be present while spraying.

**MOSQUITO BREEDING AREAS—MOSQUITO LARVICIDE**—Apply in undiluted or diluted form by ground sprayer or aircraft to known mosquito breeding sites:

**Prehatch**—Make a single application during the winter months at 1 to 2 qts. per acre.

**Larvicide**—Apply as needed during the spring and summer at 3/4 to 2 pints per acre around the perimeter of lakes, streams, ponds, swamps, marshes, estuaries and other areas of standing water (intermittently flooded areas, stagnant water, temporary rain pools, sloughs and ponds) where mosquito larvae are to be controlled.

**NOTE:** Do not use near or contaminate food crops. The use of any residual fly spray should be supplemented with proper sanitary measures including removal of breeding sources such as manure in and around buildings.

## CAUTION:

Harmful if swallowed. Avoid contact with skin. Avoid breathing of spray mist. Avoid contamination of feed and foodstuffs. This product is highly toxic to bees exposed to direct treatment or residues on crops. Protective information may be obtained from your Cooperative Agricultural Extension Service. Do not apply when weather conditions favor drift of spray from areas treated.

This product is toxic to fish. Keep out of lakes, streams or ponds. Shrimp and crab will be killed at application rate recommended. Do not apply where these are important resources. Do not apply to water drainage areas where runoff or flooding will contaminate ponds, lakes, or streams. Do not contaminate water by cleaning of equipment, or disposal of wastes.

Rinse equipment and containers and dispose of wastes by burying in non-crop land away from water supplies. Containers should be disposed by punching holes in them and burying with wastes, or by burning (keep out of smoke).

**IMPORTANT**—Users should observe the usual precautions concerning application of oil-containing products to crops during high temperatures, since many crops are more susceptible to oil injury.
