Insects: For control of Phorid fly and Sciarid fly-Apply 2 lbs. of dust per 60 ft. single house or 1 lb. of dust per 2,000 sq. ft. of bed surface. Make a thorough application of dust as soon after picking as possible. Repeat applications as necessary-usually, once a week.

Diseases: For control of Verticillium (brown spot) bendae), Dactylium (mildew) soft decay, cobweb), Mycogone (bubbles), and Trichoderma (green mold)-use 1 lb. per 4,000-sq. ft. of bed. Apply at 3 to 7 day intervals until buttons begin to form; also between "breaks" Verticillium (dry bubble), as required. Dactylium (soft decay)
