The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below.

- 1) Since the sites on this proposed label have already been approved (May 21, 1982 accepted label), the proposed label is acceptable. It is understood that this label will replace all previously approved labels.
- 2) As new labels are prepared, modify the label declaration for sumithrin in accordance with the Sumithrin Standard as follows:

"3-phenoxybenzyl-(1RS, 3PS; 1RS, 3SR)-2,2-dimethyl-3-(2-methylprop-1-enyl)cyclopropanecarboxylate"

- 3) The source product (EPA Reg. No. 1021-1366) depicted on your CSF dated 9/23/91 has been canceled and does not reflect the correct registration number for Multicide Intermediate #2086. Submit a revised and complete Confidential Statement of Formula accordingly. It should be noted that the Confidential Statement of Formula dated

12/4/90 did not include the original propellants. We note that the propellants have been added to the CSF dated 9/23/91.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists.

Do not apply directly to food. Do not apply while food processing is underway. After spraying, wash all equipment, benches, shelving, etc., where exposed food will be handled, with potable water. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use.

Remove pets: birds and cover fish aquariums before spraying.

PHYSICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

STORAGE AND DISPOSAL

Storage: Store in a cool area away from heat or open flame.

Disposal: Do not reuse empty container. Wrap container and put in trash collection.

SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT.
APPLY IN SHORT BURSTS.

To Kill Flies, Mosquitoes, Small Flying Moths and Gnats: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and destroy fallen insects.

To Kill Cockroaches, Ants and Crickets: Contact as many insects as possible with the spray in addition to thorough spraying of all parts of the room suspected of harbouring these pests.

Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, food storage areas and wherever these pests are suspected of hiding. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary.

To Kill Carpet Beetles: Directly spray as many insects as possible. Spray both interior and exterior of upholstered furniture. Both top and bottom of rugs and carpets should be sprayed thoroughly. Also treat shelves, closets, areas under furniture and wherever these insects are seen or suspected. Repeat as necessary.

To Kill exposed stages of store beetle, flat grain saw-toothed grain beetle, Indian Meal Moth, Mealworm, and other pantry insects: Find and destroy items from pantry. Spray present. Place clean pantry shelves have dried. Repeat.

To Kill Sowbugs, Centipedes, and other insects: Spray as many insects as possible in all parts of the room suspected. Attention should be paid to sinks, behind stoves and

To Kill Fleas and Flea Larvae: Spray sleeping quarters after spraying registered flea and tick repellent. Enter treated area.
