- for aerial application:
 - by fixed wing aircraft, observe a 300 ft. buffer zone between field and houses
 - by helicopter, observe a 200 ft. buffer zone between field & houses
 - do not apply when wind velocity exceeds 3 mph.
 - do not apply in an open area of less than 10 acres
