An initial slug addition of 1.90 to 4.75 fluid ounces of Leeder 202-V Water Treatment per 1000 gallons of water to provide a concentration of 16 to 40 parts per million of Leeder 202-V Water Treatment based on the total weight of water in the system, is recommended. Repeat initial dosage until control is evident.

Subsequent slug additions of 0.47 to 4.75 fluid ounces of Leeder 202-V Water Treatment per 1000 gallons of water (4 to 40 parts per million of Leeder 202-V Water Treatment) should be employed every 2 to 5 days, or as needed.
