HAY MANAGEMENT RECOMMENDATIONS

Do not store untreated hay near high moisture treated hay.

Store hay off of the ground under a roof.

If hay is stored in a barn, be certain there is good ventilation.

Harvest all hay at the proper moisture and stage of maturity.

NOTE: FRESH CUT Plus Preservative is not a substitute for good management practices.

FIRST AID

IF IN EYES:

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
- Call a poison control center or doctor for treatment advice.
- Have the product label with you when you contact the poison control center or doctor.

IF ON SKIN OR CLOTHING:
