DIRECTIONS FOR USE.

POCKET GOPHER CONTROL

HAND PROBE METHOD: FIND UNDERGROUND RUNWAY BY PROBING WITH IRON BAR OR BROOMSTICK. INSERT ONE TABLESPOONFUL OF BGS ONE-SIXTEEN GOPHER BAIT, COVERING OPENING SECURELY WITH SOIL OR SOD MOUND. DO NOT PERMIT DIRT TO SIFT INTO BURROW AND COVER BAIT. REMOVE ANY SPILLED OR SCATTERED SEED AND BURY. ONE POUND WILL TREAT ONE TO FIVE ACRES DEPENDING ON GOPHER POPULATION AND NUMBER OF MOUNDS TO BE TREATED. SEE WILDLIFE CAUTIONS.

ARTIFICIAL BURROW BUILDER METHOD: FOLLOW MANUFACTURER'S INSTRUCTIONS FOR THE EQUIPMENT USED TO APPLY BGS ONE-SIXTEEN GOPHER BAIT. APPLY 1 TO 2 POUNDS OF BAIT USING A 20 TO 30 FOOT ROW SPACING INTERVALS. APPLY ONLY WHEN SOIL CONDITION IS PROPER TO INSURE FORMATION OF A GOOD ARTIFICIAL BURROW. SEE WILDLIFE CAUTIONS.

CONTAINER DISPOSAL

DO NOT REUSE EMPTY CONTAINER. DESTROY IT BY PERFORATING OR CRUSHING AND BURY DEEPLY IN A SAFE PLACE. DO NOT CONTAMINATE WATER BY CLEANING OF EQUIPMENT OR DISPOSALS OF WASTES.
