PREBAITING

PLACE UNTREATED GRAIN FOR SEVERAL DAYS IN AREAS OF SPARROW ACTIVITY PRIOR TO PLACEMENT OF SPARROW-CRACKS. PREBAIT SITES SHOULD BE LOCATED IN AREAS CLOSE TO BUILDINGS TO MINIMIZE THE HAZARD TO BENEFICIAL BIRDS AND OTHER WILDLIFE. PREBAITING SHOULD BE CONTINUED DAILY UNTIL UNTREATED GRAIN IS ACCEPTED READILY.

BAITING


SPARROW-CRACKS SHOULD NOT BE PUT OUT UNTIL UNTREATED GRAIN HAS BEEN ENTIRELY CONSUMED OR CLEANED UP. DO NOT USE SPARROW-CRACKS IF NON-TARGET BIRDS OR MAMMALS ARE FEEDING IN THE TREATMENT AREA.

AMOUNT OF SPARROW-CRACKS TO BE USED WILL BE DETERMINED BY THE AMOUNT OF UNTREATED GRAIN CONSUMED DAILY. SPARROW-CRACKS SHOULD BE SCATTERED IN THE SAME LOCATIONS AS THE UNTREATED GRAIN. PICK UP AND DESTROY ALL DEAD BIRDS DAILY. UNEATEN SPARROW-CRACKS SHOULD BE PICKED UP AND DESTROYED WHEN THE DESIRED CONTROL HAS BEEM OBTAINED.
